Section 3. The Code of the Village of Chester Chapter 29 Alarm Systems, Section 29-10, FALSE ALARM CHARGES is amended replacing subsection 'A' in its entirety with the following:

SUSPENSION AND REVOCATION OF PERMIT is hereby removed in its entirety.

A. Any owner or lessee of property having an alarm device or system shall pay to the Village a charge for each and every false alarm during an Alarm Permit Year, as follows:
