Section 1. The Code of the Village of Chester Chapter 98, Zoning, §98-35.1, Alternate Member, is amended to replace §98-35.1, in its entirety, with the following:

**“§98-35.1 ALTERNATE MEMBERS:**

A. Up to three alternate members of the Zoning Board of Appeals shall be appointed by the Mayor, subject to the approval of the Board of Trustees, for terms of five years.

B. The Chairperson of the Zoning Board of Appeals may designate an alternate member to substitute for a member when such member is unable to participate on an application or matter before the Board. When so designated, the alternate member shall possess all the powers and responsibilities of such member of the board. Such designation shall be entered into the minutes of the initial Zoning Board of Appeals meeting at which the substitution is made.

C. All provisions of Village Law Section 7-712 relating to Zoning Board of Appeals member training and continuing education, attendance, conflict of interest,

compensation, eligibility, vacancy in office, removal, and service on other boards, shall also apply to alternate members.”

**Section 2.** SEVERABILITY. In the event that any clause, sentence, section or other part of this Local Law is declared to be invalid, such invalidity shall not affect the remainder of this chapter.

**Section 3.** EFFECTIVE. This Local Law shall become effective immediately upon filing with the Office of the Secretary of State pursuant to the Municipal Home Rule Law.
