Section 1. Local Law 3 of 2012, Disciplinary Hearing Procedures for Members of the Village of Chester Police Department, is amended to replace Section 7 of that local law in its entirety with the following:

"Section 7 - Appeal

In accordance with Village Law Section 8-806, the determination of the Village Board shall be subject to review by the Supreme Court in the judicial district in which the Village of Chester is located. Any such review shall be in the manner provided for by Article 78 of the Civil Practice Law and Rules, provided that the proceeding must be commenced within sixty (60) days from the date of the Village Board's determination."

Section 2. Repealer. All Local Laws, Ordinances or parts of Local Laws or Ordinances inconsistent or in conflict with these Ordinance are hereby repealed as to said inconsistencies and conflicts.

Section 3. Severability. In the event that any clause, sentence, section or other part of this Local Law is declared to be invalid, such invalidity shall not affect the remainder of this chapter.

Section 4. This Local Law shall become effective immediately upon filing with the Office of the Secretary of State pursuant to the Municipal Home Rule Law.
