WATER REPORT: Water Treatment Operator Thomas Becker was present and read report as follows:

1= Daily filtration plant and Well #12 routine.

2= All unpaid water bills have been collected.

3= EFM backwashes have been done twice weekly.

4= The water Audit for 2012 has been completed and our unaccounted for water amount was 8%.

5= we installed an 8 inch valve on the old water feed line to Camp LaGuardia to isolate a water main break.

6= We have shut water off at many of the vacant homes in the Village to avoid water leaks. 7=Joe spent some time out cleaning sidewalks.

8= I have a price quote of \$4200.00 dollars from the Pall corp. for future technical support at the filtration plant to cover us after our warranty runs out in March. This will give us 24/7 support for one year.

WHEREAS, vacant structures that are not maintained for months at a time degrade and depreciate the value of the vacant structure as well as the value of surrounding properties; and

WHEREAS, lending institutions that hold mortgages on said vacant structures do not always provide the contact information of a responsible party; and

WHEREAS, Assembly Bill A.88 and Assembly Bill A.824, currently pending, would make it mandatory for lending institutions to provide contact information of responsible parties regarding vacant structures; and require good faith in obtaining a foreclosure; and

WHEREAS, the Mayor and the Village Board of the Village of Chester supports the passage of said Bills.
