WATER REPORT: Water Commissioner, Thomas Becker read water report as follows:

- 1= Daily Filtration plant and Well #12 routine.
- 2= At Well #12 Weekly Iron and Manganese testing has been done.
- 3= At the Filtration plant twice weekly EFM filter membrane cleanings have been done. Once weekly Iron & Manganese tests have been done to check on the increase in levels during the winter months. A new Heating & air conditioner was installed in the office
- 4= We worked at the Police garage to remove old lumber and frameworks from past Halloween Parades and built new shelving using some of the old lumber.
- 5= The water audit has been completed and our unaccounted for water is at 17 % for 2015.
- 6= Our Walton Lake Permit Report for 2015 is almost complete.
- 7= We replaced several break line on the 2001 box van. The 2015 pickup has been serviced.
- 8= We are in the process of updating our SDS sheets for the water dept. garage, Filter plant and Well #12.

RESOLUTION OF THE VILLAGE BOARD OF THE VILLAGE OF CHESTER TO SET A TIME AND PLACE FOR A PUBLIC HEARING REGARDING THE ADOPTION OF LOCAL LAW # 3 OF 2016 TO ESTABLISH A SIX-MONTH MORATORIUM PROHIBITING THE PERMITTING, CONSTRUCTION OR INSTALLATION OF COMMERCIAL POWER GENERATING FACILITIES IN WITHIN THE VILLAGE

WHEREAS, the Village Board of the Village of Chester is considering the adoption of regulations with respect to the construction and operation of commercial power generating systems in residential districts within the Village; and

WHEREAS, the Village Board wishes to enact a local law establishing a moratorium on the permitting, construction or installation of any new commercial power generating systems within the Village of Chester during the time that the aforesaid code amendments are being developed and implemented; and

WHEREAS, the Village Board of the Village of Chester is empowered by the State to adopt such local law pursuant to Municipal Home Rule Law; and

WHEREAS, moratoria are listed as Type II Actions under §617.5 of the State Environmental Quality Review Act (SEQRA) and, as such, are not subject to review under SEQRA; and

WHEREAS, the Village Board of the Village of Chester wishes to hold a public hearing on the proposed moratorium local law on March 14, 2016, at 6:30 p.m., at the Chester Village Hall, 47 Main Street, New York 10918, providing an opportunity for the public to be heard; and

NOW, THEREFORE, it is hereby

RESOLVED, that a public hearing be held by the Village Board regarding the adoption of the aforesaid moratorium local law at p.m. on March 14, 2016, at 6:30 p.m., at the Chester Village Hall, 47 Main Street, New York 10918; and be it further

RESOLVED, that the Village Clerk is hereby directed to refer the aforesaid proposed local law to the Orange County Planning Department for review pursuant to General Municipal Law §239-m; and it is further

RESOLVED, that the Village Clerk is hereby authorized and directed to cause public notice of said hearing to be given as provided by law.
