# **Discussion - Industrial Park Road Improvement:**

Village Attorney, Ian L. Schlanger, gave a presentation to the Board on traffic issues coming from the industrial park during certain hours, in particular with making a right turn from Nucifora Blvd. on to Rt94/east. The traffic issues were recently studied in conjunction with the site plan approval process associated with Isomedix. Mr. Schlanger explained that it was the Planning Board's recommendation that the issue be dealt with. Mr. Schlanger explained the concept of creating an improvement district whereunder the costs of any of the road work involved could be passed onto the properties benefited by the improvement.

Village Planning Board Chairman, Rick Ramsdell, Mr. James Sweeney Esq., counsel for Isomedix, and Phil Greesley, a traffic consultant for Isomedix was also present.

Mr. Sweeney then gave a presentation on the issues involved and the mechanics behind the creation of an improvement district. Next, Mr. Greesely gave a presentation on the traffic issues and proposed solution.

**STREET REPORT:** No report.

**WATER REPORT:** Water Commissioner, Thomas Becker, read his report as follows:

- 1= Daily Filtration Plant and Well #12 routine.
- 2= At the Filtration Plant EFM filter membrane cleanings have been done twice each week. The high Iron & Manganese levels on the raw water have finally dropped down.
- 3= Ted Marks has given us a price to install a Whole building surge protector at Walton Lake Filtration plant. \$6121.55 will protect the generator transfer switch and the electronic devises in the filtration plant.
- 4= Our 2014 water audit has been completed and we have an unaccounted water amount of 7%.
- 5= the annual lake report and annual water withdrawal reports have been completed and sent to DEC.
- 6= Joe has continued to do snow removal on the sidewalks.
- 7= Last Month we had 2 water service line freeze ups and several meter freeze ups along with many internal pipes frozen throughout the Village.
- 8= Our two required bacteria samples for February were taken to the lab.
- 9= I have been working on organizing and updating water main our mapping.
- 10= On Walton lake dam I met with Dominic Green, John Vero and Tom Bell to find out how to get the county to get involved with the Engineering needed for the Dam.

Discussion was had about the purchase of a building surge protector for Walton Lake Filtration Plant.

**PARK& RECREATION:** Park & Recreation Director Walter Popailo was present and announced the following:

- Ice rink at Community Park was closed for the season. Once the ice melts the rink turns into a floor hockey rink and court for basketball. Park & Recreation will be installing the netting for the basketball hoops.
- Discussion was had about the Chester Fireworks for 2015. The Chester fireworks are scheduled for Saturday, July 11, 2015. The event is going to begin at 4:00 p.m., and will be an evening celebration with bands, bandstands and vendors. The fireworks will begin at dusk.

- Camp registration is underway and if you need any information about camp and/application you can go to town website at <a href="www.Chester-ny.gov">www.Chester-ny.gov</a>. Chester Park & Recreation has a Facebook page at Chesternyparks.
- Park & Recreation hired a new camp Director Kaitlyn Moran.
- Chester Senior Center was painted by the Bellvale Community and they will be replacing the ceiling. The Bellvale Community incurred the cost of the labor, paint and ceiling tiles.
- This year the Park & Recreation has scheduled three movie nights for 2015. Time and Location TBD.

#### **OTHER BUSINESS:**

Mayor mentioned that the next monthly business meeting will be changed to April 13, 2015.

A motion was made by Deputy Mayor Carole Duffy, second by Trustee John T Bell, to change monthly business meeting from April 6, 2015 to April 13, 2015. Motion unanimously passed.

Andrea Armstrong, of Unison, gave a presentation to the Village Board on Unison's Offer to buyout current cell tower leases. The Village Board will table this item until further notice in order to review and discuss the offer by Unison to buyout current cell tower leases.

**WHEREAS**, the Village of Chester ("Village") was named in a lawsuit entitled BT Holdings, LLC v. Village of Chester and the Village of Chester Board of Trustees, under Orange County Supreme Court Index No. 1480-2015; and

**WHEREAS**, the Village requires Special Counsel to undertake representation and a defense of the Village in the aforesaid litigation; and

# **NOW, THEREFORE**, it is resolved as follows:

**Section 1**. Feerick Lynch MacCartney, PLLC ("FLM"), is authorized to present this litigation to the Insurance Company for the Village to have the Insurance Company defend and indemnify the Village. Until such time as the Insurance Company provides a defense, FLM is authorized to appear and defend the Village and shall be compensated for all services performed for the Village with regard to the litigation entitled BT Holdings, LLC v. Village of Chester and the Village of Chester Board of Trustees, under Orange County Supreme Court Index No. 1480-2015 at the hourly rate of \$250 (plus all disbursements reasonably incurred), and in accordance with the terms and conditions of the Retainer Agreement between the Village and FLM dated December 5, 2014. Those services shall be paid by the Village separate and in addition to any services Special Counsel has previously been retained to handle for the Village.

**Section 2**. This Resolution shall be effective immediately.
