A motion to accept the Police Department report, as read, was made by Trustee Alan Battiato, second by Trustee Elizabeth A. Reilly. Motion unanimously passed

**STREET REPORT:** Street Superintendent, Charles Bono, read his report as follows:

Road work continues in the industrial park with the new Steris building. The new catch basins are working on Elizabeth Lane and the old catch basins where the driveway was put in have been eliminated. The street openings for the drainage and sewer lines are in the process of being repaired. They have drilled and pinned the old concrete and poured new concrete into the street openings where the old concrete was removed to put in the new lines. They have to wait for the new concrete to cure and then they will add the blacktop on top of the concrete.

The ditch line where the new drainage pipe was installed on Hambletonian Ave. has been blacktopped.

We have replaced some sidewalks and curbing in various areas of the village that was deteriorated or collapsed. Those areas are as follows:

- 1. 60' of curbing on Main Street in front of Derosa's Deli.
- 2. A small section of the island by the Magoya Japanese Restaurant
- 3. 20' of sidewalk by 23 Academy Ave.
- 4. 80' of curbing on Whispering Hills Drive from Section 4300-4700 towards the circle.

Received a phone call on Wednesday October 5, 2016 from the Village of Chester Police Department to recover what was once call the hut in the Park and Ride. Apparently, a tractor trailer had back into the hut while trying to turn around and somehow hooked the hut while pulling forward and dragged it onto Chester Blvd. When we arrived, we turned off the power that went to the hut and removed the remaining pieces from the street onto the grass and swept up all the broken glass. The next day I notified Dan Coots from the NYS DOT about the hut and he said that he would notify Coach USA, who is in charge of the maintenance and have the remains removed.

The leaf vac is ready to go and we are in the process of transferring over the leaf box to another dump truck for another season for our leaf pick up. At this time, village residents can bring leaves out to the curb to be picked up. We ask that you do not put out leaves in or near storms drains or by catch basins as this will prevent water from getting to storm drains and catch basins and will cause the water to back up onto the streets. Also, please keep sticks, and stones separate from leaves as this will clog or damage the leaf vac and cause

downtime. All weekly pick up, including leaf pick will end on December 1<sup>st</sup>, so we urge village residents to put out their leaves at their earliest convenience.

The New York State Salt bid for 2016-2017 year was awarded to Cargill Inc. The price of salt this year will be \$70.90 a ton.

The village snow ordinance will go into effect on November 1<sup>st</sup> to April 15<sup>th</sup>, at which time there is no parking on any village street between the hours of 3:00am to 6:00am.

We continue with the normal weekly sweeping, moving and picking up of bags and brush.

WATER REPORT: Water Commissioner, Gary Green Jr., read his report as follows:

- 1) Daily filter plant & well operations

- 5) Chlorinated main for building 4 Meadow Hill Development
- 6) Installed meter pit at beginning of Ricky lane and worked with contractor on new service install. 800 feet of 1 ½ underground pex.
- 7) Fixed service line leak at intersection of maple and north Hudson street. Pin holes in copper due to stray current electrolysis.
- 8) Monthly samples and THM's were taken to lab for testing
- 9) Patched leak on fiberglass tank at filter plant
- 10) Continue water line mark-outs for Dig Safe N.Y.

# FRONTIER COMMUNICATIONS FRANCHISE AGREEMENT

**WHEREAS**, Frontier Communications of New York, Inc., a New York corporation, has applied for a franchise agreement to permit it to provide cable television service in the Village of Chester; and

**WHEREAS**, the Frontier Communications of New York, Inc. requires a franchise to operate in and on Village streets; and

**WHEREAS**, Frontier Communications of New York, Inc. submitted a proposed franchise agreement to operate a cable television system within the Village of Chester; and

WHEREAS, a Public Hearing was held before the Chester Village Board on September 12, 2016; and

**WHEREAS**, the Mayor and Trustees have considered the submissions by Frontier Communications of New York, Inc., the comments of the public and written submissions by or on behalf of other providers of cable television service in the Village;

# NOW, THEREFORE, BE IT

**RESOLVED**, by the Village Board of the Village of Chester that

- 1. The Board finds that Frontier Communications of New York, Inc., possesses the technical ability, financial condition and character necessary for the grant of a cable television franchise and that the proposed franchise agreement complies with federal and state law and the franchise standards required by the New York State Public Service Commission, subject to review and approval by that Commission.
- 2. The Board finds it would serve the public interest of the citizens of the Village to approve granting a franchise to Frontier Communications of New York, Inc.
- 3. Subject to the conditions mentioned below, the Board does hereby grant to Frontier Communications of New York, Inc. a non-exclusive franchise to construct, own and operate a cable television system within the Village of Chester to Frontier Communications of New York, Inc. for a term of fifteen (15) years from the date of approval by the New York State Public Service Commission.

**BE IT FURTHER RESOLVED**, that the Mayor be hereby authorized to execute a franchise agreement with Frontier Communications of New York, Inc., substantially in the form presented to this meeting, with an express proviso added to the effect that, at such time as the Village chooses to acquire and use telecommunications equipment for PEG purposes, the franchisee shall be required to provide a monetary grant to the Village for the purpose of acquiring the necessary equipment, and with such other non-substantive modifications thereto as may be agreeable to the Mayor and the attorney for the Village, it being understood substantive modifications, should

any such be proposed, must be presented to this board for further consideration and approval.

Motion by <u>Trustee Elizabeth A. Reilly</u> Seconded by <u>Trustee Brian J. Boone</u> Approved by vote of <u>5</u> in favor and <u>0</u> opposed.

A motion to approve the transfer current employee Joseph Phillips from the Street Department to Water Department, was made by Trustee Elizabeth A. Reilly, second by Deputy Mayor Christopher Battiato. Motion unanimously passed.
