STREET REPORT: Street Superintendent Charles Bono was present and read report as follows:

As of November 1st the snow ordinance is in effect in which there is no parking on any village street between the hours of 3:00am to 6:00am.

We spent a couple of days blacktopping with the drag box.

Orange and Rockland will be extending the existing 2" plastic gas main from the intersection of Maple Ave. down towards lower Hudson St.

We continue with the normal weekly sweeping and picking up of bags and brush.

A majority of our time has been spent picking up leaves.

We would like to remind the village residents that all weekly pick up, including leaf pick up will end December 1st, so we urge everyone to put out their leaves at the earliest convenience.

As of October 31st, Orange County DPW has stopped maintaining the Park and Rides. The state has transferred the maintenance over to Coach USA.

WATER REPORT: Water Treatment Operator Thomas Becker was in attendance and read his report as follows:

- 1= Daily Filtration plant and well # 12 routine daily.
- 2= We are currently doing two more monthly coliform test samples. The OCHD is no longer sampling THM and HAA5 for October were completed.
- 3= At the Filtration plant twice weekly EFM membrane cleanings are being done and CIP cleanings were done in October. I received the price quote from the Pall Corp. and a quote for the electrical supplies needed to protect the equipment in the Filter plant from power surges.
- 4= Biweekly mowing have been done at all water facilities.
- 5= All meters were read and bills went out.
- 6= Fall water main flushing has been completed.
- 7= We have started to clean main water curb boxes throughout the Village.
- 8= The water dept. employees have completed a confined space class.
- 9= Gary and Joe helped the Highway dept. pave for two days.
- 10= We continue to do water line mark outs daily.
- 11= I would like to have permission to go out to bid on a new pickup.

PARK& RECREATION: Park & Recreation Director Walter Popailo was not in attendance. No report submitted.

Water Filtration Property Tax Exemption - 2016:

WHEREAS the Real Property Tax Law, Section 406(3), provides the authority for each taxing district in which municipally owned property used in such manner is located to grant a whole exemption from real property taxes levied by that taxing district; and

WHEREAS such exemption for the Village of Chester Water supply site real property would provide a direct and immediate benefit for the taxpayers and water users of the Village of Chester, which would enhance real property ownership, encourage industrial and commercial development, and exemplify a spirit of intermunicipal cooperation between the County of Orange and the Village,

NOW, THEREFORE, be it

RESOLVED that the Village Board of the Village of Chester, on behalf of the Village of Chester, its taxpayers, water users and citizens hereby petitions the County of Orange to grant a whole exemption from Orange County real property taxes commencing for the calendar year 2016 for the parcel of real property identified as follows in the Town of Monroe:

RESOLUTION ON HIRING SPECIAL:

WHEREAS, the Village of Chester, New York Board of Trustees ("Board") realizes that litigation may be forthcoming and that Special Counsel representing the Village Board is critical to defend the best interests of the Village and its resident taxpayers; and

WHEREAS, the hiring of Special Counsel does require the expenditure of funds, but the expenditure of those funds is necessary to safeguard the Village from being exposed to unfounded litigation threats and demands for monetary payments that are not warranted under the law and which would cost taxpayers extraordinary sums of money if the Village is not properly represented by experienced Legal Counsel; and

WHEREAS, Special Counsel well versed in municipal matters has been identified in the Firm of Feerick Lynch MacCartney, Esqs. who undertake representation of municipalities in the greater Hudson Valley area

NOW THEREFORE, it is resolved by the Village Board as follows:

Section 1. All "WHEREAS" paragraphs are incorporated herein by reference as though set forth in full herein.

Section 2. The Firm of Feerick Lynch MacCartney, Esqs. is hereby retained by the Board of Trustees to undertake all services necessary with regard to threats of pending litigation and any litigation filed as well as related matters concerning land use and zoning at the hourly rate of \$250 per hour plus expenses. The retention of Feerick Lynch MacCartney, Esqs. as Attorneys for the Board of Trustees for the Village of Chester, New York shall authorize said Special Counsel to review and obtain all Village documents and consult with all Village Officials and Village Employees as well as Planning, Zoning, Land Use and other Consultants for the Village.

Section 3. This Resolution shall take effect immediately.
