POLICE REPORT: Police Chief Peter Graziano was present and read his report as follows:

HIGHWAY REPORT: Street Superintendent J. Thomas Bell was not present; no report was submitted.

WATER REPORT: Water Treatment Operator Thomas Becker was present and read his report as follows:

- 1= Daily Filtration Plan and Well #12 routine.
- 2= Backflow preventing devices are still being tested. A second notice has gone out to the remaining locations that have not responded to our first request. If it becomes necessary a third notice will be sent out with a shut off deadline.
- 3= At the Filtration Plant we have continued to be on site to perform EFM backwashes on both filter skids. The contract between the Village and Cappola to upgrade the Filtration plant has been finalized. I have been in contact with the Pall corp. in reference to the continued filter membrane issues on skid B and they are going to send a system specialist down to the plant within the next two weeks.
- 4= A service line leak has been repaired on Maple Ave.
- 5= I am in the process of finalizing a Water Contract with Brain Leetjens for the property on Shaleen Dr.
- 6= All unpaid water bills have been collected. We have 9 locations shut off most of which are vacant. Some off our Quarterly bills are still outstanding at this time but they are on a different schedule for collection.
- 7= On 2-15 2012 I met with Steve Gagnon at the OCHD to review and update our Stage 2 Disinfectant Byproducts monitoring requirements.
- 9= Within the next three weeks we should be receiving a check for \$24.426.00 from the NYSDOT this is money that they have held from the water main project on West St.
- 10= Joe will be attending a Backflow device recertification class tonight and tomorrow night.
- 11= On March, 27 the water dept. will attend a free excavator safety seminar at the Brookside Manor put on by Dig Safely NY.
- 12= We still have no new information on the Walton lake Dam, the free water customers or the purchase of property along Walton Lake shoreline.
- 13= I would like to have the Boards approval to have the Whispering Hills warranty inspection done and the Walton Lake Intake structure.
