STREET REPORT: Street Superintendent Charles Bono was present did not submit a report.

WATER REPORT: Water Treatment Operator Thomas Becker was present and read report as follows:

- 1= Daily filtration plant and well #12 routine.
- 2= Lawns were moved twice in the past month at all water facilities.
- 3= At the filtration plant EFM membrane cleanings were done twice weekly, the number 2 air compressor has been repaired and the plant was cleaned after the repairs.
- 3= At well #12 we are experiencing problems with the master control panel that is original to the 1969 installation. I am getting pricing to upgrade the panel.
- 4= We are continuing to clean valve boxes in the Village and I would like to thank Police Chief Graziano for the use of a Police car when we cleaned the valve boxes on Brookside Ave & Rt 94.
- 5= I had a meeting at the Orange County Health Dept. to review concerns with our future THM & Haa5 testing. They were very helpful with information and options we can use to reduce the levels of these byproducts in our water.
- 6= We did our quarterly testing for THMs & Haa5s for October.
- 7= Water bills have gone out for our October billing.
- 8= We started flushing water mains today.
- 9= Monthly reports for October have been sent to the O.C.H.D.

Water Filtration Property Tax Exemption - 2015:

RESOLVED that the Village Board of the Village of Chester, on behalf of the Village of Chester, its taxpayers, water users and citizens hereby petitions the County of Orange to grant a whole exemption from Orange County real property taxes commencing for the calendar year 2015 for the parcel of real property identified as follows in the Town of Monroe:
