STREET REPORT: Street Superintendent, Charles Bono, was absent. Mayor John Tom Bell, read report as follows:

Our equipment for snow and ice control have been installed. We still have a few more pieces of equipment to service.

I spoke to Jeff Weisbrot at Henderson Equipment on Friday January 6th 2017. Our new truck is at their garage in Watertown N.Y. As of to date they do not have a start date to install the equipment on the truck. He said he would call me sometime this week to let me know with a start date.

We were called out 8 times during the month of December to deice and clear the streets. 7 out of 8 storms were what we call nuisance storms, which consisted of snow squalls or showers and Freezing Rain with accumulations of under an inch. However, the storm on December 17, 2016 was significant which produce around 6" of snow. As of to date we have used over a 120 ton of salt and 16 ton of salt sand mix. After each storm, the equipment was wash and serviced for the next storm.

We have been going around picking up Christmas trees a couple times a week when possible. Just a reminder that the last day the street dept. will be picking up Christmas Trees will be January 31, 2017.

Spoke to Dan Coots from the State DOT who is in charge of the Park and Ride. Dan said that they are working on replacing the hut in the Park and Ride that was run over a tractor trailer.

Thanks to the great work by the Village of Chester Police Dept. they were able to identify the tractor trailer that ran over the hut and are waiting for the trucking company's insurance company filing the claim. He said that it would take 45 days from the time they ordered it. He also said that he was going to call Coach USA and see if they could expedite it.
