STREET REPORT: Street Superintendent, Charles Bono, read report as follows:

We spent a few days going around and putting down topsoil and grass seed where the edge of lawns that were damaged from the snow plows and snow blower.

We have been breaking down and removing some of our snow removal equipment and prepping them for summer.

We have been cutting down some trees and clearing some brush on our new property behind the village hall parking lot.

We have started our weekly mowing.

We continue with the normal weekly sweeping, picking up of bags and brush and the collection of garbage.

Tires can be brought to The Town of Chester Highway Dept. the 2nd and 3rd week of May during the hours of 9:00 am-3:30 pm, however they must be off the rims.

Received a letter from Orange and Rockland pertaining to street lighting options. Recently the New York State Public Service Commission issued an order directing O & R to offer additional Light Emitting Diode ("LED") street lighting options to municipalities in its service territory beginning April 1, 2017. This applies to all failed luminaries in SC No. 4 (Service Classification No 4 -Public Street Lighting – Company Owned) will be converted to LED at no cost to your municipality. O & R will continue to offer on a calendar year basis, the replacement of up to two percent of its streetlights ("Two Percent System Threshold") on a system –wide basis. Beginning April 1, 2017, all replacements under the Two Percent System Threshold will apply only to LED conversions

Received a letter from the New York State Department of Transportation. The enacted State fiscal year 2017-18 Budget includes 438.1 million in Consolidated Local Street and Highway Improvement Program (CHIPS) funding for municipalities to support the construction and repair of highways bridges, highway railroad crossings, and other facilities that are not on the State highway system. Our apportionment for the 2017-18 state fiscal year is \$52,158.88, which is a \$52.00 increase from last year. The Budget also includes (1) a \$100 million PAVE NY appropriation to assist municipalities with rehabilitation and reconstruction of local highways and roads; (2) a new

\$65 million Extreme Winter Recovery (EWR) capital appropriation to help local governments make necessary repairs to highways and bridges. Our apportionment balance for the PAVE NY appropriation is \$11,905.78, which is a \$11.87 increase from last year. Our apportionment balance for the new Extreme Winter Recovery capital appropriation is \$8,852.19. The total amount between the CHIPS appropriation, PAVE NY appropriation, and the Extreme Winter Recovery capital appropriation will be \$72,916.85, which is an increase of 14% from last year's budget

We continue with the normal weekly sweeping, picking up of bags and brush and the collection of garbage.

Resolution No.: 21 of 2017

A Meeting of the Village Board of the Village of Chester was convened on May 8, 2017 at 7:00 p.m.

The following Resolution was duly offered and seconded to wit:

RESOLUTION TO AMEND CERTAIN PROVISIONS OF THE VILLAGE'S EMPLOYMENT POLICIES MANUAL

WHEREAS, the Village of Chester's New York Employment Policies Manual ("Employment Policies Manual"), sets forth the terms and conditions of employment for Village of Chester (the "Village") employees; and

WHEREAS, in a continuing effort to improve and enhance the working relationship between the Village and its employees, the Village Board desires to amend certain portions of the Village's Employment Policies Manual as set forth below.

NOW THEREFORE, it is resolved by the Village Board as follows:

Section 1. All "WHEREAS" paragraphs are incorporated herein by reference as though set forth in full herein.

<u>Section 2.</u> The Village Board hereby directs and authorizes that the following provisions of the Employment Policies Manual be amended to read as follows: (Any new language that will be incorporated into the Employment Policies Manual is shown in **bold** and any existing language that will be removed is shown in strikethrough.)

5. <u>New Employee Training/Probationary Term</u>

All new employees receive on-the-job training. As a new employee, you will spend your first several months of employment with the Village in a probationary status. Newly hired employees are on probation for period of ninety (90) days. Once you have successfully completed the ninety (90) day probationary period, your status then changes to one of either regular full-time employment or regular part-time employment, depending upon the position for which you are hired.

During the probationary period, employees are not eligible for, do not accrue and are not entitled to any benefits, including but not limited to vacation leave, personal leave, and paid sick leave. Further, you will not be entitled to participate in any Village employee benefit plan as described in this Manual or otherwise during the probationary period. As a new employee, you will be taught the proper way to do your job as well as proper procedures for work tasks and office reporting requirements. The methods you will be learning have been developed to meet the Village's specific requirements for a safe and productive work experience. They are designed to help you work smarter, not harder.

6. <u>Employee Classifications & Definitions</u>

The term "Anniversary Date" as used in this Manual means the anniversary each year of the date of an employee's first day of employment with the Village. The Anniversary Date is used by the Village to calculate paid vacation leave and other forms of paid leave and/or benefits for eligible employees.

9. <u>Base Wage & Salary Step Increases For New Hires</u>

Newly hired employees may be eligible for increases to their base wage after six (6) full months or after twelve (12) full months of employment from the date of hire. The determination of whether a newly hired employee is eligible to receive an increase to their base wage is solely vested with the Village Board. Similarly, the amount of the increase is at the discretion of the Village Board.

12. <u>Vacation Leave</u>

Subject to the exceptions set forth below, vacation leave is provided by the Village, for full-time employees only, as follows:

a) First Fiscal Year of Employment–A newly hired employee is not entitled to, nor does a newly hired employee accrue, any paid vacation leave during their probationary period. Once a newly hired employee successfully completes their probationary period (90 days), the newly hired employee begins to accrue vacation leave at a rate of one-half (1/2) vacation days per month actually worked until the end of the Village's fiscal year in which the employee was hired. during the first year of employment, full-time employees are entitled to paid vacation leave of five (5) work days (i.e., 1 work week). However, such leave may not be taken during the first six (6) months of employment with the Village, and such paid leave does not accrue during the probationary period.

b) Second Fiscal Year of Employment - during the second fiscal year of employment, which shall begin on the first day of the Village's fiscal year occurring after such employee was hired, (commencing on and determined by the eligible employee's Anniversary Date full-time employees are entitled to paid vacation leave of five six (56) work days (i.e., 1 work week).

c) Third through Ninth Fiscal Years of Employment - during the third through ninth fiscal years of employment (**beginning on the first day of the fiscal year**-commencing on and determined by the eligible employee's Anniversary Date each year), full-time employees are entitled to paid vacation leave of fifteen (15) work days (i.e., 3 work weeks).

d) Tenth through Fifteenth Fiscal Years of Employment - during the tenth through fifteenth fiscal years of employment (**beginning on the first day of the fiscal year**-commencing on and determined by the eligible employee's Anniversary Date each year), full-time employees are entitled to paid vacation leave of twenty (20) work days (i.e., 4 work weeks).

e) Sixteenth Fiscal Year of Employment and Beyond - during the sixteenth fiscal year of employment and beyond (**beginning on the first day of the fiscal year** commencing-on and determined by the eligible employee's Anniversary Date each year), full-time employees are entitled to paid vacation leave of twenty-five (25) work days (i.e., 5 work weeks).

f) Notwithstanding anything contained in this Manual, an employee will not accrue or otherwise be entitled to vacation leave during any month for which he or she is in an out-of-pay status, including but not limited to leave under the FMLA, sick leave, Workers' Compensation leave, Short-Term/Long-Term disability leave, or while subject to any form of discipline.

g) In any given year, an employee may take no more vacation than that to which the employee is entitled as set forth herein, except for any partial carryover from the immediately preceding year as set forth in subsections 11 (h) and 11 (j) of this Manual.

h) Subject to the provisions of subsection 11 (j) of this Manual, certain portions of vacation leave accrued during a given one (1) year period (**beginning on the first day of the fiscal year** commencing on and determined by the eligible employee's Anniversary Date) may be carried over to the following year only and not for any longer period. Notwithstanding anything contained herein, the failure to timely use any carryover vacation leave will result in a complete forfeiture of such carryover vacation leave.

i) If you quit or are discharged by the Village, you are entitled to payment of all accrued vacation leave, except as set forth in subsection 11(h) of this Manual. Notwithstanding anything contained herein, all vacation leave is based upon completed service time as set forth in this Manual; if you quit or are discharged by the Village prior to the completion of service time as determined by your Anniversary Date, you will not have accrued or be entitled to vacation leave for that period in which service time was not completed. There are no pro rata accruals of vacation leave.

j) Employees who do not wish to take the maximum amount of vacation leave to which they are entitled, **based upon the foregoing** and as determined by their Anniversary Date in any given one (1) year period, may elect the following options:

13. <u>Personal Leave</u>

All full-time, non-probationary employees of the Village are eligible for three (3) days of paid personal leave each **fiscal** year, except for the first full year of employment, based upon and as determined by their Anniversary Date. Entitlement to personal leave days shall commence and be credited upon at the beginning of employee's Anniversary Date each **fiscal** year. Employees who are in probationary status are not eligible for, do not accrue and are not entitled to any personal leave days until the completion of the probationary period. Employees who have successfully completed their probationary period are eligible for one (1) day of paid personal leave during the employee's first full year of employment with the Village, after which time the employee will be eligible for three (3) days of paid personal leave as set forth herein. Part-time employees and temporary employees are not eligible for or otherwise entitled to any personal leave days.

14. <u>Sick Leave</u>

All full-time, non-probationary employees are eligible for twelve (12) days of paid sick leave during each year. based upon and as determined by their Anniversary Date. Entitlement to paid sick leave shall commence and be credited **on the first day of the fiscal year** upon the employee's Anniversary Date each year. Employees who are on probation are not eligible for, do not accrue and are not otherwise entitled to paid sick leave. Employees who have successfully completed their probationary period **accrue paid sick leave at a rate of one (1) day of paid sick leave per month actually worked until the end of the fiscal year**. are eligible for nine (9) days of paid sick leave during the employee's first full year of employment with the Village.

37. <u>No Workplace Violence</u>

(a) (v) Possessing any weapon in the workplace. A "weapon" includes, any firearm, gun, explosive device or substance, lethal or debilitating chemical or gas, or any dangerous or deadly weapon of any description, including but not limited to a handgun, rifle, shotgun, dangerous knife, dagger, razor, imitation pistol, or any other item defined as a firearm or weapon under New York State Penal Law but is not limited to loaded and unloaded firearms, knives or any other device intended to cause harm or which threatens to cause harm;

RESOLVED, that the Village Clerk, as provided in Zoning Code §98-39, refer Proposed Local Law # 4 of 2017 Amending Zoning Code §98-20 (E) Off-Street Parking and Loading, Computation of Spaces in B-1 Zone, to the Village of Chester Planning Board, for a report pursuant to Village Code §98-40(A) and to the Orange County Department of Planning for review in accordance with General Municipal Law § 239-m(3)(a)(ii).

RESOLUTION in support of EFC grant funding for the replacement of Pump Station No. 3

WHEREAS, pursuant to Intermunicipal Agreement with the Town of Chester and the Town of Monroe, the Village of Chester is a part of the Moodna Basin Joint Operating and Maintenance Commission ("Joint Commission"), whose personnel operate and maintain the sewerage infrastructure of the Village and of Town Sewer Districts in the Towns of Chester and Monroe; and

WHEREAS, following professional review of the state of the infrastructure maintained by the Joint Commission, the Sewer Administrator of the Joint Commission and the Joint Commission's consulting engineers, Lanc & Tully, P.C., have recommended on an urgent basis the replacement and rebuilding of the Village of Chester's Pump Station No. 3; and

WHEREAS, pursuant to such Intermunicipal Agreement, Pump Station No. 3, in addition to handling essentially all the sewage flow from the Village of Chester, pumps sewage originating from portions of the Town of Chester Sewer Districts, including flows from the Surrey Meadows development in the Town of Chester; and

WHEREAS, the Joint Commission's consulting engineers have prepared plans and specifications for the replacement of Pump Station No. 3, and the Village has begun the process of soliciting proposals for the purchase of necessary equipment and the engagement of a contractor; and

WHEREAS, pursuant to the New York State Water Infrastructure Improvement Act (WIIA) and the New York State Intermunicipal Water Infrastructure Grants Program (IMG), the replacement of Pump Station No. 3, as recommended by the Joint Commission, to pump sewer flows from the Village of Chester and from Sewer Districts in the Town of Chester, qualifies for consideration to receive a grant or grants from the New York State Environmental Facilities Corporation; and

WHEREAS 6 NYCRR § 617.5(c)(7) provides that the replacement of the pump station and the application for a grant in support thereof is a Type II SEQRA action not requiring further review under 6NYCRR Part 617; and

WHEREAS the Mayor and Trustees have determined that it is in the best interest of the Village to apply for a grant pursuant to the above-described programs,

NOW, THEREFORE, be it hereby

RESOLVED that the Village Board declares that the replacement of Pump Station No. 3 is a Type II action under SEQRA and that no further SEQRA review is required, and it is further

RESOLVED that the Village shall apply for grant funding in support of the replacement of Pump Station No. 3, and it is further

RESOLVED that the Mayor, the Clerk, and the attorney for the Village and consulting engineers Lanc & Tully, P.C., and any and all other officers or agents of the Village whose participation is appropriate,

are authorized and directed to prepare, complete, execute and submit the appropriate grant applications and to do all other things necessary or proper to secure such grant or grants in support of the replacement of Pump Station No. 3.

PROPOSED LOCAL LAW AMENDING THE ZONING CODE 98-20 (E), OFF-STREET PARKING AND LOADING, COMPUTATION OF SPACES IN B-1 ZONE,

Proposed Local Law # 3 of 2017.

A local law entitled: "Amendment to Chapter 98 of the Village Code Zoning Pertaining to Off-Street Parking and Loading, Computation of Spaces in a B-1 Zone"

Be it enacted by the Board of Trustees of the Village of Chester, in the County of Orange, as follows:

<u>Section 1.</u> The Code of the Village of Chester Chapter 98, Zoning, §98-20(E), Computation of spaces, is amended to include the following:

(7) In an effort to maintain the character of the B-1 zone, in the Planning Board's discretion, all or portions of all the required off street parking for a site plan may be waived. In considering the above, the Planning Board will consider the proposed use and the proximity to available municipal parking in the area. Credit may also be given for available on-street parking. The on-street parking credit will be calculated at the rate of 1 space per 20 feet of lot frontage with available on-street parking.

<u>Section 2</u>. EFFECTIVE. This Local Law shall become effective immediately upon filing with the Office of the Secretary of State pursuant to the Municipal Home Rule Law and shall apply to all applications which have not been granted final approval.

Resolution Limiting Parking on Portion of Main Street:

WHEREAS, pursuant to Chapter 92 of the Village Code, the Mayor and Trustees are authorized to limit the time of parking in specified locations during specified hours; and

WHEREAS, from time to time the Mayor and Trustees have adopted such parking regulations, which appear in Schedule XI in Article VIII of the said Chapter 92 as Code §92-39, and

WHEREAS, subject to approval from the New York State Commissioner of Transportation, the Mayor and Trustees wish to limit the time of parking on the south side of Main Street from Elm Street to the Fire House,

NOW, THEREFORE, be it hereby

RESOLVED that, effective upon the approval by the New York State Commissioner of Transportation, the following is to be added to Schedule XI in Article VIII of the said Chapter 92 as Code §92-39, immediately after the entry for "Elm Street to driveway between Nos. 111 and 115 Main Street":

Main Street

South 2 hours/ Monday to Friday except holidays

Elm Street to the Chester Fire District property line at 81 Main Street designated Tax lot 108-2-3.22

and it is further

RESOLVED, that the Village Clerk shall enter this change in the said Schedule XI immediately upon receipt of said approval from the New York State Commissioner of Transportation.
