• Officers have been out enforcing the NYS Vehicle and traffic laws, 195 tickets were written for the month. 1,078 tickets have been issued for the year.

We spent a few more days blacktopping in the industrial park preparing to tar and chip.

We spent some time weed whacking along the curbs and sidewalks in Chester Acres, Vista Drive, June St., Valley Court, Grandview Terrace and the Industrial Park.

We completed our paving project on Leone Lane in which we paved the entire street from the intersection of Kings Hwy to about 100ft from the railroad tracks.

We continue with the normal weekly sweeping, moving and picking up of bags and brush.

WATER REPORT: Village Water Commissioner, Gary A. Green Jr. read the Water Department report as follows

- 5) Our quarterly testing was completed

- 9) We power washed the exterior of the water filtration plant.
- 10) D&N Tanks repaired the Nancy Lane tank. It took 3 days to complete the work.
- 11)Inspected and repaired roof at the Filter plant.
- 12)Inspected and repaired roof at the shop. There was some storm damage to the rear of the building.
- 13] Weekly mowing of our facilities was completed.

WHEREAS, the Village Board desires to convey such property and previously adopted a resolution to advertise the Property for sale and/or solicit bids for such Property to be further considered by the Village Board; and

WHEREAS, the Village Board has obtained a professional valuation supporting a sales price in or about the range of Three-Hundred Seventy-Five Thousand Dollars (\$370,000.00) as constituting fair and adequate market value consideration for the Property; and,

WHEREAS, the Village Board has received bid(s) to purchase such Property at a sales price within ten (10) percent of the aforementioned professional valuation and one such bidder has expressed the intent to use the Property for commercial purposes, which would further benefit the Village by returning the Property to the tax rolls and bringing potential consumers and foot traffic into the Village; and,

WHEREAS the Village Board desires to negotiate and/or accept bids for the purpose of completing the transaction for the conveyance of the Property to benefit the Village as previously set forth herein.

NOW, THEREFORE, it is resolved by the Village Board as follows:

Section 1. All "WHEREAS" paragraphs are incorporated herein by reference as though set forth in full herein.

Section 2. The Village Board hereby determines that the Property no longer serves a municipal purpose to the Village.

Section 3. The Village hereby determines that the consideration offered for the property is adequate and fair.

Section 4. The Mayor is hereby authorized to execute any and all documents necessary to negotiate, accept bids, and/or complete the transaction relating to the Property, subject to all applicable requirements and in form approved by legal counsel.

Section 5. The Mayor, and any other officer, employee or consultant as directed by the Mayor, are authorized to take any and all necessary actions to carry out the provisions of this Resolution.

Section 6. This Resolution shall take effect immediately.

PUBLIC COMMENT:

Mayor John Thomas Bell opened the meeting up to public:

Ralph Pena - I recently purchase a home on Walton Lake, its one of the beautiful places I've seen in my life. I use it for recreational purposes. I've discovered that on the westside of the Lake, Lakes Road there has been numerous amounts of trash that is seeable from the shoreline. I've personally have pulled out 100 to 200 lbs. of broken bottles, cans. I pulled out a for sale sign for a home. What I would like to do is to ask the village for help. I've learned that the lake is a water source for the Village of Chester. Talking to my neighbors, friends, some who are here with me tonight, I like to request the village perhaps provide a dumpster for us because there are about 40 or 50 car tires in there too, which is affecting the drinking water for the village of Chester. I have my own well but I'm looking at the beauty and the safety of everyone involved, not only my neighbors and friends who use it for recreational purpose but for the village residents that use it for their primary source of water. I would like to know how we could go about requesting a dumpster be provided so we can get this stuff out. We would all volunteers to get it up to the dumpster we just need if you could cart it away.

Trustee Elizabeth Reilly suggested that Water Commissioner Gary A. Green Jr. contact the town and village's garbage district provide 10 per year, so it would probably be best if the Water commissioner contact the Town of Chester Clerk's Office.

Ralph Pena - the individual that owns the property where the Bocci's restaurant use to be, Mr. Bill Brown gave us permission to put a dumpster they're if the village will provide them.

Water Commissioner asked Mr. Pena what day would they like to schedule the clean up?

Mr. Pena said jokingly, yesterday. He said he would like to schedule it before it gets too cold and if it can't be done before then maybe we can schedule it for Earth Day.

<u>David Wenger</u> of 15 June Road, I have a major problem with run-off onto my property coming from Grandview. I sent a bunch of letters to the village clerk in reference to getting some help as there is property in between, my property and Grandview. I think has originally cleaned out and hasn't been since I've been there for fifteen years. I'm just looking or advise or help on how to solve the problem, so it doesn't wash out my retaining wall and ruin my pool.

Mayor John Thomas Bell responded and stated that the Street Superintendent Charles Bono and the Village Code Enforcement Officer John Orr, were working on this. The Village does not have a right of way through the area of your property.

Mr. Wenger stated that the village could go straight through his property.

The Village does not own property behind 15 June Road, the Village Code Enforcement looked over plans and confirmed that.

Mr. Wenger was satisfied with the response from the Village. Mr. Wenger thanked the Village Board of Trustees.

Gordon Shehab asked the Village Board when will the proposed comprehensive plan be finalized.

Trustee Elizabeth A. Reilly suggested that we step up a special meeting to further discuss and the village would not take public comments as the public hearing was closed.

Mayor John Thomas Bell asked to schedule a Special Meeting on Monday, October 18, 2021, at 7: 00 p.m.

Trustee Elizabeth A. Reilly made a motion, seconded by Christopher Battiato to allow the Treasurer, Angela O'Neill to attend NYSGFOA conference Wednesday, October 6, 2021, for 9:00 a.m. to 1:00 p.m. Motion unanimously passed.
