# Request to attend a 1 Day training Class in Kingston

A motion to accept Village Code Enforcement Officer John Orr's report was made by Deputy Mayor Elizabeth A. Reilly, seconded by Trustee Anthony Laspina. Motion unanimously passed.

**STREET REPORT:** Village Street Superintendent, Charles Bono read the Street Department report as follows:

We were called out 7 times during the month of January to deice and clear the streets (they ranged from a ½" of ice to 5" of snow). During the month of January, we used a total of 120 ton of salt and 35 ton of sand salt mixture. Year to date we have used over 150 ton of salt and 35 ton of sand/salt mix. We hauled in 27 ton of sand to replenish our sand salt inventory. After each storm, the equipment was wash and serviced for the next storm.

During the month we have been going around picking up Christmas trees one or two times a week.

The igniter for the furnace that heats the office and lunchroom went out. We had to have the igniter replaced with a new igniter.

A motion to accept the Street Department's Report as read by Street Superintendent Charles Bono was made by Trustee Anthony Laspina, seconded by Trustee Brian J. Boone. Motion unanimously passed.

#### WATER REPORT

- 1) Daily filter plant & well operations
- 2) Twice per week filter cleaning
- 3) Monthly and Quarterly samples were taken to the lab.
- 4) Mark outs for dig safe NY.
- 5) We replaced the meter at 32 Leone Lane Satin Fine foods.
- 6) The generator at the Filter plant was serviced by Kinsley Power.
- 7) The Annual Water Quality report was completed and sent to the Orange County Health Department for review.
- 8) The Annual Water withdrawal report was finished and sent to DEC for review.
- 9) We serviced the Backhoe.
- 10) PDJ fire line froze and broke in the old Chester lumber building resulting in a loss of 350,000 gallons of water.
- 11) Backflow prevention testing has started.
- 12) Walton lake is 7 inches over pin level.

Deputy Mayor Elizabeth A. Reilly asked if there is anything that can be done to prevent a loss of water regarding PDJ fire line. Water Commissioner Gary A. Green, Jr stated that Old Chester Lumber Building was empty. They took it upon themselves to shut the fire/sprinkler line inside without notifying the water department. Since there was no heat, the pipes blew out around 3am. By the time Water Commissioner Gary A. Green, Jr got the call from the police department, it was 5:15am but he was able to shut off the water at 5:45am. The water department was able to calculate usage and send them a bill since it was negligence on their part. Village Code Enforcement Officer John Orr added that he sent them a notice of violation order of remedy because they can't shut down a fire service system without notification. They are supposed to contact Village Code Enforcement Officer John Orr this week to talk about how they are going to handle that matter.

A motion to accept the Water Department's report as read by Water Commissioner Gary Green

A. Green Jr. was made by Trustee Alan Battiato, seconded by Deputy Mayor Elizabeth A. Reilly. Motion unanimously passed.

# PARK & RECREATION REPORT: No report

#### **NEW BUSINESS:**

Presentation by Theresa Lewis and Lucille Rushing: NY PROJECT HOPE.

PROJECT HOPE is a federal program led by FEMA to help all families in need or in crisis. PROJECT HOPE provides coping with COVID, provides food, clothing, shelter, help with families and seniors and those with special needs. There are three organizations in Orange County that provide services though grants. Access Support for Living is a large facility that deals with mental health, developmental disabilities, and substance abuse issues. The other organizations are Mental Health Association of Orange County and Independent Living Center. Lucille Rushing is a Trained Crisis Counselor. Each Crisis Counselor is assigned to a certain zip code. They mainly provide emotional support and resiliency to children and staff in schools in Goshen and Tuxedo, for example. There are offices in Middletown Newburgh and Kingston NY. There are walk-ins for the insured and non-insured, the services are free and confidential.

Deputy Mayor Elizabeth A. Reilly asked if the Crisis Counselors are available 24 hours per day and 7 days per week or if someone can leave a message and receive a call back. Lucille Rushing stated that someone will call back, but someone is always available when the Access phone number is contacted.

# 22-5 RESOLUTION ADOPTING THE 2022 COMPREHENSIVE PLAN AND CONFIRMING SIGNIFICANCE UNDER SEQRA WITH RESPECT TO ADOPTION OF COMPREHENSIVE PLAN

**WHEREAS**, the Village Board of Trustees of the Village of Chester ("Village Board") is responsible for the preparation and adoption of the Village of Chester Comprehensive Plan, pursuant to Section 7-722 of the New York State Village Law; and

**WHEREAS**, the Village Board has determined the adoption of the 2022 Comprehensive Plan is desirable and necessary: and

WHEREAS, the Village Board retained Alan J. Sorensen, AICP, and Planit Main Street, Inc. to prepare a Comprehensive Plan in conjunction with the Village Comprehensive Plan Committee; and

WHEREAS, the Comprehensive Plan Committee held meetings, including with the Village Planner, on numerous dates including 12/2/2017; 1/27/2018; 4/5/2018; 5/2/2018; 7/19/2018; 9/12/2018; 10/18/2018; 11/15/2018; 6/4/2018; 8/1/2018; 8/19/2018; 9/19/2018; 10/5/2019, as well as a Public Hearing on the draft Comprehensive Plan on June 25, 2020, which was continued on July 16, 2020, and August 6, 2020; and

WHEREAS the Village Planner and the Village's Comprehensive Plan Committee duly prepared a Draft Comprehensive Plan; and

**WHEREAS**, the Village Board prepared a Full Environmental Assessment Form ("EAF") Part 1, 2, and 3 for the proposed action, which Full EAF has been fully reviewed by the Village Board; and

WHEREAS, upon review of the Application, the Village Board, which declared itself to be lead agency under SEQRA by resolution dated March 9, 2020, determined the project is subject to the

State Environmental Quality Review Act (ECL, Article 8) and its implementing regulations (6 NYCRR Part 617) (collectively, "SEQRA"); and

WHEREAS the Village Board compared the EAF to the thresholds for classifying this action as set forth in 6 NYCRR §§ 617.4 and determined that the project constitutes a Type 1 action pursuant to SEQRA; and

WHEREAS the Proposed Action was referred to the Orange County Planning Department pursuant to Sections 239-m of the General Municipal Law; and

WHEREAS the Orange County Planning Department recommended certain changes and minor technical revisions; and

WHEREAS the draft Comprehensive Plan was revised to address some changes requested by the County Planning Board (s); along with minor technical revisions; and

**WHEREAS**, on September 10, 2020, the Village's Comprehensive Plan Committee referred the draft Comprehensive Plan to the Village Board; and

WHEREAS, the Village Board opened its duly noticed Public Hearing on the draft Comprehensive Plan on December 2, 2020, which Public Hearing was continued at subsequent meetings on January 20, 2021, May 10, 2021, August 9, 2021, September 13, 2021, October 4, 2021, October 18, 2021, and December 6, 2021, during all of which all those people desiring to speak or submit written comments were provided the opportunity to do so and hearing from all those in attendance wishing to speak, the Public Hearing was closed on December 6, 2021; and

**NOW, THEREFORE BE IT RESOLVED** that, pursuant to SEQRA, the Village Board of the Village of Chester, based upon its review of the Full EAF, previously determined, but hereby confirms its determination that there will be no significant adverse environmental impacts as measured against the criteria for determining significance under 6 NYCRR § 617.7(c); and be it

**FURTHER RESOLVED**, this resolution is a Negative Declaration under SEQRA and the information required by 6 NYCRR § 617.12(a) is attached hereto and incorporated herein; and be it

**FURTHER RESOLVED**, the Village Board hereby directs the Village Clerk to file a copy of this resolution with (a) the Mayor of the Village of Chester, (b) the lead agency, (c) all involved agencies, (d) any person who has requested a copy; and be it

**FURTHER RESOLVED**, the Village publish a copy of the Negative Declaration attached to the resolution in the *Environmental Notice Bulletin* as required by 6 NYCRR § 617.12(c).

**FURTHER RESOLVED**, the Village Board hereby adopts the 2022 Comprehensive Plan in accordance with NYS Village Law §7-722.

# FURTHER RESOLVED, that this resolution shall take effect immediately.

This parcel can be added in legislation and there should not be an issue with adopting according to Village Attorney Brian Nugent.

# **PUBLIC COMMENT:**

Gordon Shehab of 68 High Street: Asked if the grant for Main Street revitalization was approved or if it's still pending. Village Clerk/Treasurer Angela O'Neill responded that she has not yet received the agreement, but she did receive a project ID. She was told by Senator Skoufis' office that once a project ID is issued, it's definitive but doesn't want to say its official until the agreement comes in the mail. The vision for the project was to replace the Holiday lights since we have had those from the 1980's and 1990's. The banners that are currently hanging will also be replaced. Lighting will be provided in the parking lot by the Amphitheater space. The grant is in the amount of \$100,000.

Patricia Salerno of 11 Hambletonian Avenue asked about the Nexans issue on 25 Oakland Avenue since it has been very noisy lately. Village Code Enforcement Officer John Orr responded stating that they are replacing the roof and are trying to keep it within reasonable hours but should be completed within the week. Patricia Salerno asked if the sale is final. Village Code Enforcement Officer John Orr said the sale is final, it is now an investment firm. Patricia Salerno asked if there are any environmental concerns regarding that property. Village Code Enforcement Officer John Orr mentioned that they did an environmental clean up before they left, and all looks good.

Patricia Salerno also mentioned that the Village Website is not user friendly, she would like to see the calendar updated and the website revamped. She suggested if there could be a section where the community could advertise events or where resources such as Project Hope could be researched. Clerk/Treasurer Angela O'Neill stated that someone within the village staff is being trained and has been assigned to update the village website. The goal is to have the new village website updated within 3 to 6 months. Clerk/Treasurer Angela O'Neill requested that Patricia Salerno email her with any comments and suggestions so that it is helpful to implement those concerns.

Patricia Salerno asked what it looks like now that the Comprehensive Plan is starting to work on resolutions and legislations. She wanted to know if there will ever be a public committee to work on some of those items. Mayor Christopher Battiato stated that it comes back to fixing the zoning that needs to be done. The public committee may not happen. Mayor Christopher Battiato stated in his opinion, they have their outline, and the thought is to get things in order in a timely manner. Brian Nugent said there will be a public hearing process once the legislation comes out for any of those local laws and zoning chapters. Patricia Salerno asked if there is a list of priorities that will be set. Village Code Enforcement Officer stated Chapter 11 because it gives the priorities within that chapter. Attorney Brian Nugent mentioned now that the village has adopted the plan, the zoning must follow even system with the plan. There is flexibility in these laws. That would be a situation where the planner would work on the legislation based on the Comprehensive Plan, present that to the board and then from there they might work on it, have a public hearing & get some input from the community and get specifics before it gets adopted.
