A motion to accept Clerk/Treasurer's report as read by Clerk/Treasurer Angela O'Neill was made by Trustee Brian J. Boone, seconded by Trustee, Alan Battiato. Motion unanimously passed.

A motion authorizing Clerk/Treasurer to post the budget modifications was introduced by Deputy Mayor Elizabeth A. Reilly and seconded by Trustee, Anthony Laspina. Motion unanimously passed.

BUILDING REPORT: Absent, no report submitted.

STREET REPORT: Village Street Superintendent, Charles Bono read the Street Department report as follows:

We spent some time repairing catch basins in the industrial park and on June Road.

We spent a couple days blacktopping in Whispering Hills Dr., Main Street and the Industrial Park.

Replaced a section of sidewalk where the water dept. repaired the water main by 5 High Street.

We spent a few days trimming branches and bushes that were blocking street signs.

We have been working up at the dump preparing an area for our brush pile.

We started removing the old body off the 2006 International and preparing the chassis for the new body.

We dug out an area by the amphitheater near the stage for the pavers.

Mayor Christopher Battiato asked Street Superintendent Charles Bono if anyone has gotten back to him regarding the generator. Street Superintendent Charles Bono stated that he received a quote from the third person on 9/9/2022 but the lead time was off so he will research a bigger generator to see if the availability is closer to their timeframe. The larger generator will run from the Street garage to the fuel pump. The third person will get back to Superintendent Charles Bono this week.

Deputy Mayor Elizabeth A. Reilly asked Superintendent Charles Bono if he heard back from the railroad regarding the signs. Superintendent Charles Bono said no but he will reach out again to see what could be done. There are already two signs on Greycourt Avenue, one sign on Sanford Avenue and one sign right before the bridge. The sign right before the bridge is the oldest one. Deputy Mayor Elizabeth A. Reilly will drive by to see what condition it is in and will let Superintendent Charles Bono know to see if he could change the sign right before the bridge. Mayor Christopher Battiato mentioned that there was talk of placing reflectors on the signs but it's ultimately up to the railroad department to decide that. Superintendent Charles Bono will contact the railroad department again before there are any other issues in that location.

A motion to accept the Street Department's Report as read by Street Superintendent Charles Bono was made by Trustee Alan Battiato, seconded by Trustee Anthony Laspina. Motion unanimously passed.

WATER REPORT: Water Commissioner, Gary A. Green, Jr read the Water Department report as follows:

- 1. Daily filter plant & well operations.
- 2. Twice per week filter cleaning.
- 3. Monthly samples were taken to the lab.
- 4. Mark outs for dig safe NY.
- 5. Backflow preventer testing continues.
- 6. Meter replacement continues.
- 7. Mowing of Water facilities.
- 8. Calibration of production meters at Plant and Well house was completed by TAM Enterprises.
- 9. We retired the water service at 95 Brookside Ave.
- 10. We installed block heater and fluid in the generator at the Plant.

- 11. We attended a seminar for credit hours.
- 12. We purchased new scale for chlorine at the Plant.
- 13. Emergency purchase of 3 turbidimeters and 2 controllers at the Plant. Installation should be performed by next week.
- 14. We painted the outside trim and the doors at the Well House.
- 15. Walton lake is 18 inches below pin level.
