- 2. 2023-2024 SEWER: Sewer bill collection continues. Installment #4 is due by 3/31/2024. Unpaid sewer balances as of 3/31/2024 will be re-levied on to the 6/1/2024 Village Property Tax Bill.
- 3. **BUDGET AMENDMENT:** On 12/11/2023, the Village Board authorized the purchase of a 2021 Dodge Durango Vehicle for the building dept. Capital Project Funds' monies were used to make the purchase. Seeking board approval to create a budget amendment to the H02 fund for the expense of \$30,975.00. WATER DEPT.** TRANSFER TO H01 CAPITAL PROJECTS FUND: Requesting Board approval to transfer \$150,000 from F Fund to the H01 Fund for the purpose of purchasing additional cellular water meters as part of the ongoing capital project. The motion was introduced by Deputy Mayor, Elizabeth A. Reilly and seconded by Trustee, Brian Boone. The motion was unanimously approved.

The building inspector, John Orr requested board permission to surplus his old vehicle. Deputy Mayor, Elizabeth A. Reilly asked that we hold off on this. The Village Board agreed.

Trustee, Brian Boone asked the building inspector if the new smoke shop to be opened in the village understands the Village's position on the opt-out of selling marijuana items. John Orr stated they are aware, and he also had a conversation with the police department on this matter.

Deputy Mayor, Elizabeth A. Reilly questioned the Moffat house repairs. John Orr replied that they have been in touch and recently dropped off a building permit application. No additional has been done in several weeks.

A motion to accept the building report as presented by Building Inspector/Code Enforcement Officer, John Orr, was introduced by Trustee, Anthony Laspina and seconded by Deputy Mayor, Elizabeth A. Reilly. The motion was unanimously approved.

STREET REPORT: No report submitted.

WATER REPORT:

- 1] Daily filter plant and well operations
- 2] Twice per week filter cleaning
- 3] Monthly and quarterly samples were taken to the lab.
- 4] Mark outs for Dig safe NY continues.
- 5] Worked with contractor to replace service line from curb stop to the house at 9 Vista Drive, There were pinholes in the copper line.
- 6] Meter replacement project continues.
- 7] Flushing at the schools and Whispering Hills weekly to maintain chlorine residual continues, weather permitting.
- 8] We worked with a contractor to install a 4" service line for the new building at 7 Greycourt Avenue.
- 9] We brought our scrap metal to the recycle yard.
- 10] I completed an 8-hour backflow tester recertification class.
- 11] A resampling of UCMR5 was completed.
- 12] Maintenance was performed on the air compressor at the water filtration plant.
- 13] We replaced the heat element/probe on the CHIN skid at the water filtration plant.
- 14] The Lake is 5 inches above pin level. In mid-December it was 17 inches above pin level and there were residents complaining. The Town of Monroe cleaned the screens and brought the lever down by 12 inches.

A motion to accept the water department's report presented by the water commissioner, Gary Green, was introduced by Trustee Alan Battiato and seconded by trustee, Anthony Laspina. The motion was unanimously approved.

HISTORIAN REPORT:

On December 5th, 2023, from 1 to 3pm, the Village Historian, Aaron Lefkowitz, held
the second formal Chester Monthly Historical Strategy Meeting was held at the Village
Hall. Those in attendance were the VOC Historian, Aaron Lefkowitz, Chester Town
Historian, Clif Patrick and Chester Historical Society Trustee, Leslie Smith. As Mr.
Lefkowitz's budget includes a component for organization memberships, he spoke with
Cliff and Leslie about recommendations. The Chester Historical Society, the Orange

County Historical Society, the Association of Public Historians in NYS, the local incorporated chapter of the NYs Archeological Society, the Ontario & Western Railway Historical Society and Orange County Mineral Society were all recommended. It was mentioned that the Chester Historical Society has 2 display cases which it has no current use for and take up a notable amount of space. The display cases may be useful for rotating historical displays at a location in the village. The idea of a Restaurant Crawl through different areas of Chester such as Downtown was proposed as a public event to promote the community's businesses. Mr. Patrick agreed to forward documents related to the discussion to Mr. Lefkowitz and the meeting was ended.

- Mr. Patrick also brought up that the SUNY Geneseo Center for Local and Municipal History on behalf of the Gardiner Foundation Semi quincentennial Summer Fellowship Program is soliciting local NYS historians to apply for the program. This program will offer fellowships to fifty students from seven colleges and universities (Canisius College, Cornell University, Brooklyn College (CUNY), SUNY Geneseo, the University at Albany, SUNY Potsdam, and Stony Brook University). This program will place a college student fellow in the historian's office in the summer of 2024 to work with you on public-facing projects commemorating the 250th anniversary of American Independence, broadly construed. The Geneseo Center for Local and Municipal History shares with local historians a simple but important goal: to present history to as large an audience as possible. The program will benefit local historians by providing them with the energy, commitment and expertise of the program's faculty mentors and their talented student fellows. The Geneseo Center for Local and Municipal History at SUNY Geneseo will pay the student fellows. Faculty mentors from the participant colleges and universities and the program director will visit each student fellow during the summer to provide advice and support. Each student will be available to work approximately 150 hours over the course of the summer of 2024.
- After contacting the Village Clerk for formal Village Board approval, Mr. Lefkowitz
 received confirmation and is proceeding with the application. As a member of the Orange
 County Semi Quincentennial Commission, Mr. Lefkowitz will actively be doing both
 work on Chester Rev War History as well as other projects in the County including more
 archeological and museum activities.
- In the interest of the preservation and restoration of historical structures within the Village, Mr. Lefkowitz has been looking at what programs for grants and other forms of funding could be made available. Avenues of Private, State and Federal financing are possible have been researched for future use.
- On December 15th, at 2pm, Mr. Lefkowitz came to the Village Hall and signed his Oath of Office as the Village Historian.
- On January 4, 2024, from 1 to 1:30pm, Mr. Lefkowitz met with the Village Clerk/Treasurer, Angela O'Neil, regarding future projects and related matters. The Chester Historical Society's display cases, which they wish to have use with another organization, were proposed to be used for public display of rotating historical artifacts.

Mr. Lefkowitz would get the sizing of the cases and follow up on this later. In line with his budget's membership section, Mr. Lefkowitz requested vouchers to join the Chester Historical Society and the Incorporated Orange County Chapter of the New York State Archaeological Association.

A motion to enter the Historian's report to the record was made by Trustee, Brian Boone and seconded by trustee, Anthony Laspina. The motion was unanimously approved.

President of the Kiwanis Club, Mr. Ray Presky and Maureen requested permission to conduct the 29th Annual Kiwanis 5K Race through the Village of Chester. A motion to grant permission provided a certificate of insurance is issued naming the Village of Chester additionally insured was introduced by Trustee, Alan Battiato, seconded by Deputy Mayor, Elizabeth A. Reilly. The motion was unanimously approved.

WHEREAS the Village Board wishes to solicit public comment prior to the adoption of a local law that would provide for the addition in the Village Code for property exemption for Volunteer First Responders.

The Village Clerk is hereby directed to publish a Notice of Public Hearing for the proposed adoption of a Local Law to add Article IV to Chapter 89 of the Village Code regarding certain property exemptions for Volunteer First Responders. The Village Clerk is authorized to publish notification for the Public Hearing to be held on February 5, 2024, at 7:00 p.m. and, the Village Clerk is directed to proceed with all appropriate notifications and

required publications of the Notice of Public Hearing and proposed Local Law as required by law and as recommended by Special Counsel for the Village.

Section 3. The Mayor and any Village officer, employee or consultant as directed by the Mayor is hereby authorized to take any and all actions necessary to carry out the provisions of this Resolution.
